**of Construction works of student and university dormitories within Project
“Education for Social Inclusion” – CEB F/P 1746 (2011)**

The Ministry of Education, Science and Technological Development, of the Republic of Serbia (hereinafter referred to as “The Purchaser”) is financing procurement of works from a loan received from the Council of Europe Development Bank (CEB) - F/P 1746 (2011), concluded on February 16th 2012, for the realization of the Project: “Education for Social Inclusion”, from which is going to be financed procurement of works under this contract.

The objective of this contract is construction, reconstruction and upgrading works of student and university dormitories on two locations: Palic and Pozarevac. In order to improve the living condition of the students in dormitories, the facilities will be constructed, reconstructed and upgraded.

This public procurement is divided into 2 (two) lots:

Lot 1: UR Palic (constructions works on facilities No. 3, 4, 5 and 5a, 6.1, 6.2 and 6.6, with Landscaping and Infrastructure)

Lot 2: Reconstruction and upgrade SD Pozarevac

The foreseen construction period will be as follow:

Lot 1: 360 days

Lot 2: 270 days

The works will be implemented as per FIDIC Harmonized Construction Contract General Conditions.

Public procurement will be conducted through the open international bidding procedures specified in the CEB Guidelines for Procurement of supply, works and services, version September 2011, as specified under the Framework Loan Agreement F/P 1764 (2011).

Public procurement is open to bidders from all countries in accordance with the above written CEB Guidelines.

The Commencement of the works is expected to be in the fourth quarter of 2019.

The Tender evaluation criterion is the "Lowest Evaluated Bid Price". Bids will then be ranked from the lowest to the highest price. This provision applies to both lots.

Interested Bidders may request additional information at the latest on August 1st 2019, from 10:00 to 12:00h Central European Time every working day, at the E-mail: ceb@mpn.gov.rs

A complete set of Tender Documents may be obtained after the submission of written application to the address below bearing the name of the project and referent number of tender procedure from 9:00 to 15:00h Central European Time every working day.

On the request, the Tender Documents may be sent by courier service if the transport is previously provided by the Bidder in his country. The Purchaser bears no responsibility for the delivery in such a case.

A Bid security is requested in the form of an unconditional, irrevocable and payable on first call bank guarantee issued by the bank. The amount and currency of the Bid security shall be for **Lot 1: EUR 100.000** and **Lot 2: EUR 15.000**.

The Bidders shall submit their offers in separate envelopes for each Lot. All bids must be delivered in closed envelope bearing the following additional identification marks:
