of furniture, kitchen equipment and laundry equipment for the equipping of student and university dormitories within the project “Education for Social Inclusion” - CEB F/P 1746 (2011)

The Ministry of Education, Science and Technological Development of the Republic of Serbia as a Purchaser financing procurement of goods from a loan received from the Council of Europe Development Bank (CEB) – F/P 1746 (2011), concluded on February 16th 2012, for the realization of the Project: “Education for Social Inclusion”, from which is going to be financed procurement of goods under this contract.

The objective of this contract is procurement of furniture, kitchen equipment and laundry equipment for the equipping of student and university dormitories in Palic, Beograd and Pozarevac, within the Project “Education for Social Inclusion”.

The public procurement is divided into 3 (three) lots:

- Lot No. 1 – Procurement of furniture
- Lot No. 2 – Procurement of kitchen equipment
- Lot No. 3 – Procurement of laundry equipment

Estimated value of the goods:

- Lot 1: EUR 657.031 excluded VAT
- Lot 2: EUR 223.179 excluded VAT
- Lot 3: EUR 20.023 excluded VAT

The procurement of goods includes the delivery, installation, testing, training and commissioning of equipment according to the Technical specification, including all necessary smaller construction works, in order to complete the installation, testing and commissioning of the supplied equipment.

Public procurement will be conducted through the open international bidding procedures specified in the CEB Guidelines for Procurement of supply, works and services, version September 2011, as specified under the Framework Loan Agreement F/P 1764 (2011).

Public procurement is open to bidders from all countries in accordance with the above written CEB Guidelines.

This commencement period for the implementation of this contract is the second quarter of 2022.

The Tender evaluation criterion is "Lowest Evaluated Bid Price". Bids will then be ranked from the lowest to the highest price. This provision applies to all lots.

Complete set of the Tender Documents may be obtained electronically via "We Transfer" every working day from 9:00 to 15:00 hours CET, and after the submission of written application to the email address: ceb@mpn.gov.rs, bearing the name of the project and referent number of tender procedures.

Bid security is requested in the form of an unconditional, irrevocable, and payable on first call bank guarantee. The amount and currency of the bid security shall be 2% of value of submitted Bid per Lot (EUR). Bid Security shall be submitted separately for every Lot.

The Bidders should submit their bids in separate envelopes for each Lot. All bids must be delivered in one closed envelope bearing the following additional identification marks:
